- Develop and maintain various financial models to forecast future cash balances, and financial performance, and other metrics as necessary.
- Prepare and analyze monthly profit and loss statements and collaborate with various departments to provide commentary on key drivers behind variances to budget/forecast.
- Prepare presentations for senior and executive management related to financial performance and other ad-hoc topics as applicable.
- Assist with data aggregation and cleansing of information included with the data warehouse to report on quarterly and annual revenue details and customer profitability.
- Liaise and collaborate with accounting, finance, sales, operations, and other organizational personnel to ensure the accuracy of financial statements and integrity of forecasted information.
- Participate on special teams & support initiatives as required.
