- Function as liaison with customers to assess their evaluation of product and to maintain satisfactory relationships
- Analyze and administer programs for rejections, charge backs, returns, corrections of defective materials and shipped pieces
- Establish and maintain liaisons with various departments to obtain, exchange, interpret, and supply information with regard to sustaining the quality managements system in all departments
- Administer plant scrap programs
- Participate in plant cost reduction/improvement program
- Record keeping in order to document and sustain the quality management system and scrap program
- Participate in plant continuous quality improvement activities
- Maintain ISO 14001 and IATF16949 Certification including but not limited to audit preparation, accompanying the third-party auditor, and response preparation to applicable audit findings.
- Assists in all phases of inspection including first piece inspection, PPAP, receiving and in-process inspection
- Create and revise documentation and graphics defining manufacturing specifications, procedures, and guidelines
- Develop new approaches to solve problems identified during quality activities



- Communicate significant issues or developments identified during quality activities and provide recommended process improvements to management
- Facilitate the supplier PPAP process, including but not limited to, maintaining the database, analyzing packages, communicating/follow-up action plans, and submitting applicable Part Approval packages to the customer.
- Lead and maintain the Corrective Action Report (CAR) process
- Investigate, track and maintain customer return database
- Maintains role as leader or team member in support of 8D problem solving sessions, Advance Quality Planning programs, internal quality system audits, capability studies/analysis, supplier quality projects, other projects associated with throughput and/or quality.
- Review, update, process FMEA/Control Plans and process flow charts
- Provide Quality Department support to all departments
- Adherence to established safety policies, procedures and practices

- Supports the organization's goals and values
