- Tax Provision Coordinates quarterly and year-end tax provision calculations for all foreign entities and prepares tax provision calculations for international aspects of U.S. Federal income tax return (e.g., Subpart F income, GILTI, foreign tax credits, etc.)
- Tax Compliance Oversees income tax compliance process for foreign entities and prepares and/or reviews international aspects of U.S. Federal income tax return (e.g., Form 5471s, Form 8858s, Form 1118, etc.)
- Tax Planning Participates in U.S. international and foreign income tax planning initiatives, including modeling potential implications and effectively working with business partners and outside advisors
- Transfer Pricing Prepares global transfer pricing analysis and documentation, including
  assisting with the development of intercompany transfer pricing policies, analysis of
  annual intercompany transfer pricing, preparation of annual transfer pricing studies by
  external consultants and preparation and/or review of BEPS reporting compliance filings
- Tax Audits Oversees tax audits and controversies involving foreign entities and international-related aspects of our U.S. Federal income tax filings
- Intercompany Financing Activities Works with Treasury, Legal and other internal
  partners to develop and execute tax-efficient intercompany financing and repatriation
  alternatives based on Management's initiatives
- Special Projects Responsible for leading special projects involving foreign or U.S. international tax related initiatives, including tax due diligence and integration projects
- Research Responsible for conducting research related to tax accounting, tax compliance, tax planning and audit support as needed, including monitoring changes in foreign and U.S. international tax laws and determines impact on the
